
Join in with us

This allows people to make donations to Dane's page, to acknowledge and remember him and also raise much needed funds.



A Leaf for A Life

If you have used Edward's Trust, you may want to buy "A Leaf for A Life." The leaf will be inscribed with the name of your loved one, and hung in our garden at the National Memorial Arboretum in Staffordshire, where you can visit for quiet contemplation.



Tribute Pages

Funerals

One way to celebrate the life of someone special is by asking family and friends to donate to a charity instead of buying flowers. Funeral directors can organise a collection and ensure Edward's Trust receive the money, or you can set up and share a Just Giving page (see the instructions above).



Legacies

Could you help our families with a gift in your will? These gifts are exempt from Inheritance Tax, which could be reduced further if you leave 10% or more to charity.
