Making a regular gift to Edward's Trust is an amazing way to support us as it allows us to plan for the future in the knowledge that your support will be there. By setting up a regular donation, you will automatically join The Kite Club, our community of Edward's Trust supporters who have pledged to help bereaved families by giving a regular donation.

You can join the Kite Club in one of two ways:

1. Set up a regular payment through Just Giving. Go to the home page on our website, click on the pink "Donate" button towards the top of the page and follow the instructions. Please note that Just Giving will take a fee from your transactions (unless you decide to cover the costs) which are 1.9% plus 20p every time a payment is made. If you choose to Gift Aid your donation, there will be an extra 5% charged to ET on the gift aid amount. You don't need to fill in this form as we will receive your details through Just Giving.

2. Fill in this form and set up a standing order directly with your bank. This form can be completed electronically and sent via email to fundraising@edwardstrust.org.uk To set up a monthly/regular standing order you will have to instruct your bank, either through online banking or talking to your bank directly. This option has a few more steps for you to carry out; however, there are no fees charged and a standing order is easier to cancel than a direct debit.
